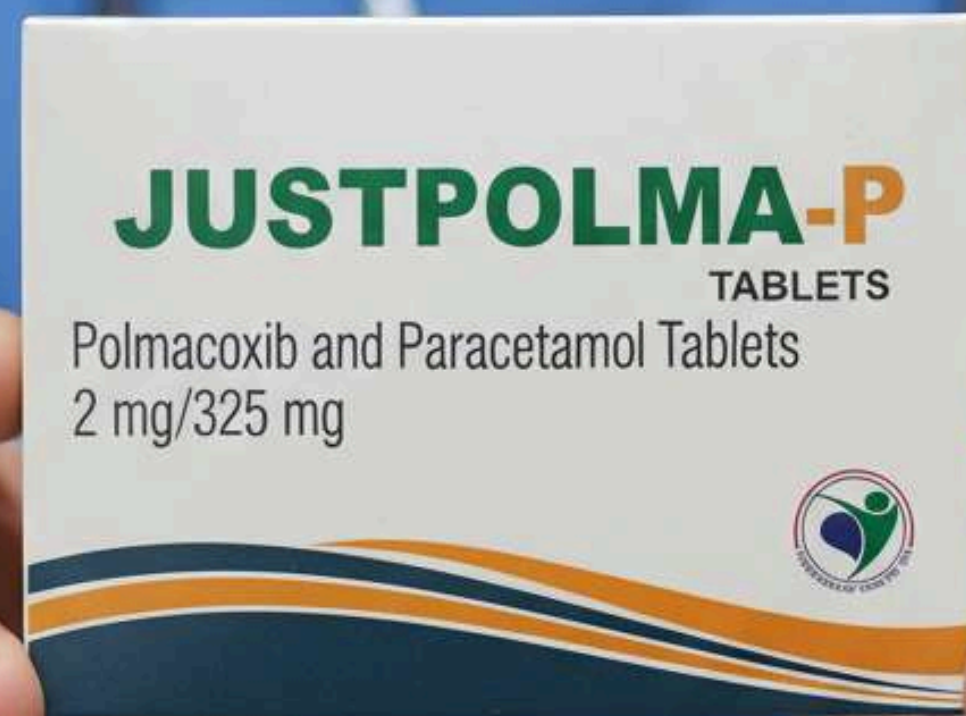

- Carbonic anhydrase binding → added cardiovascular safety

- Central inhibition of prostaglandin synthesis → rapid analgesic & antipyretic effect

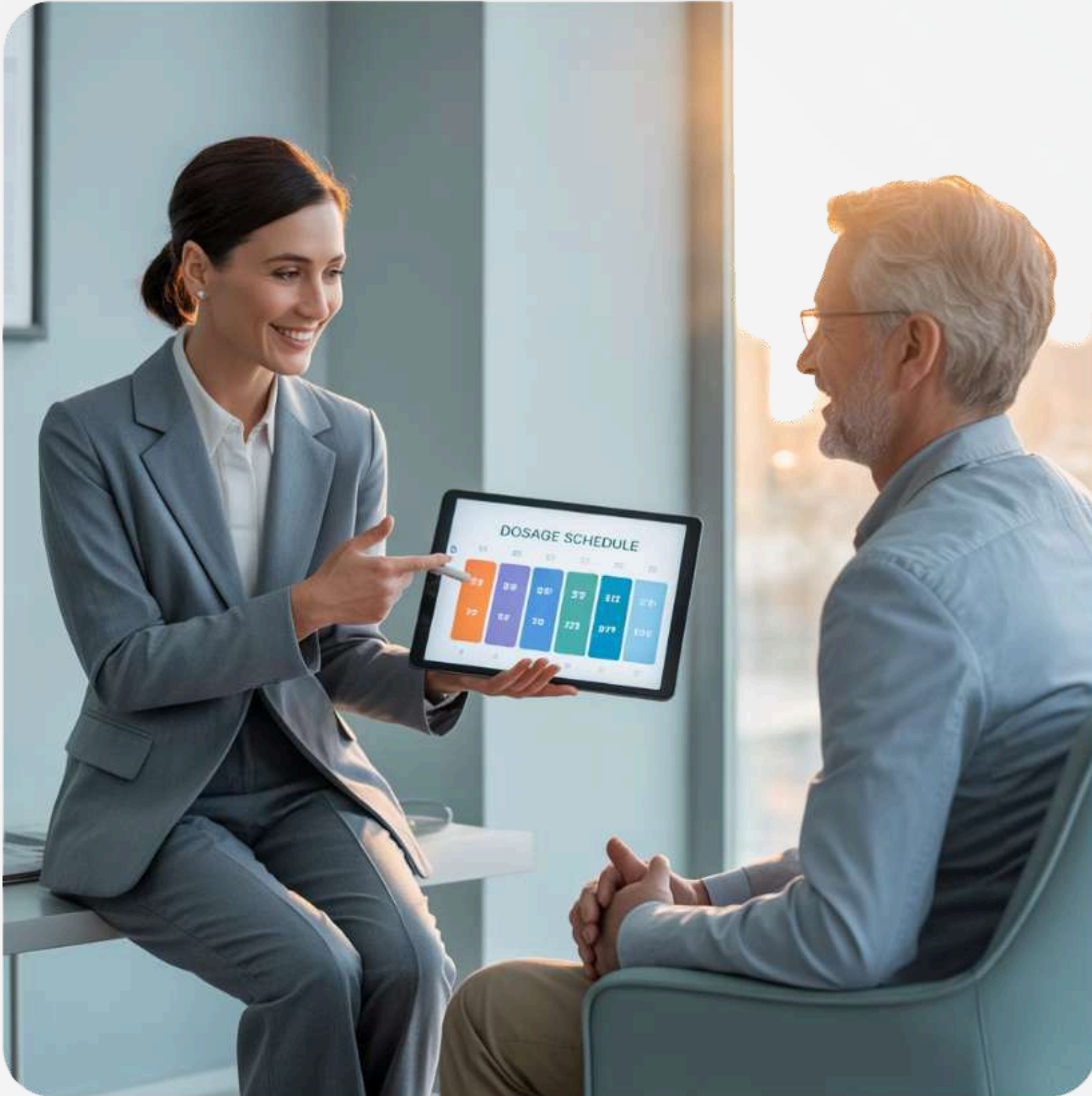

Dosage & Administration

1 Tablet once or twice daily after meals



Timing with meals helps reduce potential gastric irritation

Safety & Tolerability

 Generally Well-Tolerated

Common Side Effects

- Mild GI upset
- Dizziness
- Fatigue
- Rare hepatotoxicity with prolonged PCM use

Contraindications

- Severe hepatic/renal impairment
- Known hypersensitivity to Polmacoxib, Paracetamol or NSAIDs
- Pregnancy & lactation (use with caution)
